7. NEW BUSINESS

A. Annual Sewer Service Charge Hearing to Collect Sewer Service Charges on the County Tax Roll – Resolution No. 2019-917

President Bollay announced it was the time and place for the annual hearing and decision whether the District's sewer service charges for fiscal year 2019-20 should be placed on the County tax roll for collection as allowed under Ordinance 6. President Bollay asked District Administrator McDonald if the District had received any written or oral objections or protests by the owners of a majority of the parcels described in the report. Ms. McDonald responded that none had been received.

President Bollay reported that a letter sent on June 19th to all properties applying for a new sewer connection during the past fiscal year had informed these property owners of the District policy to collect the annual sewer service charges by means of the County tax roll and the annual hearing date. The Notice of Hearing had been published in the *Santa Barbara News-Press* on June 27th and July 4th and a Service Charge Report (listed by Assessor Parcel Numbers and Address) has been and remains available for inspection to advise any interested person of the service charge for a property in fiscal year 2019-20. District Administrator McDonald verified that the Affidavit of Mailing of the Notices of the Hearing to new customers had been signed by Board Secretary Barrett and that a Statement of the Secretary certifying that the service charge report was in order was ready to be signed.

President Bollay called for the adoption of Resolution No. 2019-917 directing the filing with the County Auditor of the Report of Sewer Service Charges for Fiscal Year 2019-20, which shall be placed on and collected by means of the County tax roll.

B. Administration & Operations (A&O) Committee Meeting - Report

The minutes of the A&O Committee meetings on June 27th and July 2nd were distributed.

Director Bollay reported the Committee met on June 27th to prepare for the July 2nd joint meeting with Montecito Water District (MWD) Strategic Planning Committee. It approved and worked on an educational power point presentation on the methods of treating recycled water and the technology to be used by the pilot project, and reviewed a proposed draft joint resolution of the MSD and MWD Boards, stating their intent to serve the Santa Barbara Cemetery with recycled water. The Committee also drafted a list of terms of agreement for the pilot project water, serving the full cemetery with recycled water, and undetermined future recycled water projects. Director Bollay noted that the Committee also discussed a proposed joint press release, and the status of ongoing capital projects.

Director Bollay reported the joint committees met on July 2nd, and MWD reported on the status of the hydrogeological study. At the meeting, MSD General Manager Gabriel and Engineering Manager Poytress gave the presentation on recycled water, and the Committees discussed hiring Jane Gray of Dudek to consult on environment review of recycled water projects. Staff from both Districts will meet with Ms. Gray prior to the next joint meeting on July 29th.

The joint committee discussed the proposed joint resolution. MWD staff was directed to edit the document as needed for its board and to return it to MSD staff for review with a goal for both boards to approve a resolution at their July Board meetings.
