Request of Cearnal Collective, architect for the owners, Montecito Sanitary District, to consider Case No. 20BAR-00000-00025 for conceptual review of a new 5,085 net square foot (sf) Essential Services Building with a new 17-space parking lot, two 2,783 sf canopies to support solar panels in the parking area, one 1,183 sf solar panel canopy over the biosolids holding area, a 3,187 sf solar canopy over the MSD vehicle parking area, a 3,187 sf solar canopy over the belt press/storage area, and a new recycled water treatment system, including a 6 foot high 185 long retaining wall to create a pad, a 60,000 gallon feed water tank, a 1,500 sf water treatment enclosure, a 130,000 gallon recycled water storage tank and a 200 sf pump station. The proposed project would also validate all existing structures on the parcel. The following is proposed for demolition: existing solar canopies over the MSD vehicle area, biosolids holding area, belt press, open storage and chemical storage, and demolition of the existing 1,930 sf main office building and adjacent 8-space parking lot. The main office building would be demolished after construction of the new Essential Services Building is complete. The project includes 120,563 sq. ft. of existing and proposed landscaping. Grading for the project includes 4,650 cubic yards of cut and 1,942 cubic yards of fill. Access to the site for the public and District staff would be provided from Channel Drive. The existing access for the public from Monte Cristo Lane would be removed and the access gated. Water would be provided by Montecito Water District. Wastewater treatment would be treated onsite by Montecito Sanitary District. The project is located on a 6.3-acre parcel, Assessor's Parcel Number 009-282-001, zoned PU (Public Utilities), and known as 910 Channel Drive (1042 Monte Cristo Lane mailing address) in the Montecito Community Plan area, First Supervisorial District.

Anyone interested in this matter is invited to appear and speak in support or in opposition to the projects. Written comments are also welcome. All letters should be addressed to Planning and Development, Montecito Board of Architectural Review, Attention: Hearing Support, 123 East Anapamu Street, Santa Barbara, California 93101.
